## HOODKROFT COUNTRY CLUB 2020 MEMBERSHIP CATEGORIES

1. **Full Family Membership.** This is a two (2) person membership limited to the following: a husband and wife, a father and child, or a mother and child. A child is defined as a son or daughter eighteen (18) or less or nineteen (19) to twenty-three (23) years of age, if attending day school beyond the high-school level as a full-time student. **The cost for each additional child is \$270 for College status and \$199 for Junior status.** Privileges include use of all club facilities seven (7) days a week, advance weekend and holiday tee times.
2. **Senior Couple Weekday Membership.** Senior Couple membership – either married person being sixty-two (62) years of age or older. Privileges include use of all club facilities Monday through Friday (except holidays).
3. **Full Single Membership.** Any person eighteen (18) years of age or older. Privileges include use of all club facilities seven (7) days a week, advance weekend and holiday tee times.
4. **Weekday Single Membership.** Any person eighteen (18) years of age or older. Privileges include use of all club facilities Monday through Friday (except holidays).
5. **Senior Weekday Membership.** Any person sixty-two (62) years of age or older. Privileges include use of all club facilities Monday through Friday (except holidays).
6. **Modified Junior Membership.** Any person age nineteen (19) through age forty (40) not attending day school beyond the high-school level as a full-time student. Privileges include use of all club facilities seven (7) days a week, advance weekend and holiday tee times.
7. **College Membership.** Any person age nineteen (19) to twenty-three (23) years of age, if attending day school beyond the high school level as a full-time student. Privileges include use of all club facilities seven (7) days a week.
8. **Junior Membership.** Any person age eighteen (18) or under. Privileges include use of all club facilities seven (7) days a week.

\*\*Tee time privileges for College, Junior, and Extra Child(ren) members included on a Full Family Membership (see 1 above) are restricted to play after 1:00 PM on Saturday, Sunday and holidays.

- e. For all weekday holidays – Weekday members pay weekend green fees rate (Memorial Day, Independence Day, and Labor Day).
- f. 2020 weekday holidays – Memorial Day, Monday, May 25<sup>th</sup>; Independence Day, Friday, July 3<sup>rd</sup>; Labor Day, Monday, September 7<sup>th</sup>.
- g. The promotional first year member rate **cannot** be combined with any other early payment or stockholder discounts and must be paid in full prior to taking affect.
